## **Relevant Legislation for Compliance with SQS 8**

Two checklists are prepared for service units to observe for the compliance with SQS 8. One is a general checklist for all types of service while the other is a service specific checklist.

The ordinances are considered to be of three levels according to their significance to the service unit's operation and service delivery:

- (a) the service unit carries statutory responsibility(ies) to execute the ordinance, or the operation of the service unit is governed by the ordinance;
- (b) without understanding of the ordinance, the service unit may be easily subject to committing an offence and thus operation and service delivery of the service unit is seriously hampered; and
- (c) with knowledge of the ordinance, quality of the service may be improved.

The two checklists of relevant legislation (general for all types of service and service specific) are prepared for the purpose of complying with SQS 8. It is considered as reasonable and acceptable to confine ordinances of levels (a) and (b) in the two checklists. Ordinances of level (c) are not included in the checklists because it can hardly be exhaustive although more knowledge on these ordinances will likely bring better service. Service units may like to add ordinance(s) to the checklists according to their individual conditions and needs.
