4. The person / company named in paragraph 3 above is authorized to operate, keep, manage or otherwise have control of a residential care home of the following type : Care and Attention Home.

5. This licence is valid for 36 months effective from the date of issue to cover the period from 1 January 2025 to 31 December 2027 inclusive.

6. This licence is issued subject to the following conditions –

- (i) the operator shall, in respect of its nursing home places (as specified by the Director of Social Welfare (DSW) under the Nursing Home Place Purchase Scheme (NHPPS) or approved by DSW),
comply with section 11(1A) of the Residential Care Homes (Elderly Persons) Regulation (Cap. 459A) concerning the employment of staff; and

7. This licence may be cancelled or suspended in exercise of the powers vested in me under Section 10 of the Residential Care Homes (Elderly Persons) Ordinance in the event of a breach of or a failure to perform any of the conditions set out in paragraph 6 above.
